

**RESOLUTION 2013-35**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENWOOD SPRINGS, COLORADO, ESTABLISHING FEES FOR THE ISSUANCE, TRANSFER, RENEWAL, AND OTHER RELATED SERVICES OF RETAIL MARIJUANA LICENSES.**

**WHEREAS**, the Colorado legislature has adopted legislation that enacted a new Article 43.4 to Title 12 of the Colorado Revised Statutes, known as the Colorado Retail Marijuana Code, and

**WHEREAS**, §12-43.4-501 of the Colorado Retail Marijuana Code authorizes the establishment of fees by the local jurisdiction for the issuance, transfer or renewal of retail business licenses; and

**WHEREAS**, in Article 050.090 of the Glenwood Springs Municipal Code, the City Council recently adopted regulations concerning retail marijuana businesses located in the City of Glenwood Springs; and

**WHEREAS**, City Council has determined that it is both necessary and appropriate that license fees be established at a rate that will cover administrative expenses for the issuance, transfer, renewal and other related services of retail marijuana business licenses; and

**WHEREAS**, City Council by this Resolution will set the fees for retail marijuana business licenses, and will set a date by which any existing business shall be required to file an application for such license.


